Workshops are at the heart of Anderson Ranch's mission, providing a dynamic and immersive experience in creativity for participants of all ages and skill levels. These workshops bring together a vibrant mix of students and distinguished faculty, resulting in transformative experiences that foster artistic growth and community. In 2023, Anderson Ranch offered 162 workshops, welcoming 1,291 students from across the nation, including adults, teens, and children. Our dedicated staff, state-of-the-art facilities, and scenic campus create an inspiring environment that attracts a diverse array of participants. We are committed to making our programs accessible to promising artists from all backgrounds. Anderson Ranch provides scholarships funded by individual donors and foundations, through both endowed funds and special gifts. Scholarships are available to all eligible applicants, and we partner with 80 colleges and universities to award scholarships to advanced emerging artists. In 2023, over 20% of our workshop students received scholarship support. Our innovative artistic internship and award program supports emerging artists, offering hands-on studio experience and fostering inclusivity. Anderson Ranch also maintains a strong dedication to diversity, equity, inclusion, and belonging (DEIB) with nearly half of our faculty identifying as BIPOC, demonstrating our commitment to a welcoming and inclusive community.

Anderson Ranch offers essential on-campus amenities to enhance the experience of our program participants. These services include a dormitory, cafe, library, art supplies store, and exhibition space. By providing food, housing, supplies, and exhibition opportunities, the Ranch fosters an immersive and supportive environment for artistic growth.

The Anderson Ranch Artists-in-Residence Program supports the creative, intellectual, and professional growth of both emerging and established visual artists. Residents benefit from dedicated studio time and access to world-class facilities in an environment free from daily distractions, allowing them to focus deeply on their work. The program encourages interdisciplinary exploration and fosters a collaborative community of working artists who engage in meaningful exchanges of ideas. Residents also receive valuable feedback from esteemed visiting critics, further enriching their artistic journey. In 2023, Anderson Ranch welcomed 29 talented artists across two residency sessions.

Form 990, Part III, Line 1 - Located on five scenic acres in Snowmass Village near Aspen, Colorado, the Ranch supports the personal and professional development of artists at all levels through year-round workshops in ceramics, sculpture, photography, new media, painting and drawing, printmaking, woodworking, furniture design, and more. Our offerings include workshops, artist residencies for emerging and established artists, summer internships, visiting artist and critic programs, community outreach, and public events, providing a full spectrum of opportunities for creative individuals of all backgrounds. The Ranch's facilities include fully-equipped, state of the art studios. Our programs and events attract thousands of artists, art lovers, students, faculty, and patrons annually to this historic Rocky Mountain center.

Form 990, Part III, Line 4d - Anderson Ranch is dedicated to nurturing artists of all ages, backgrounds, and skill levels, offering diverse educational opportunities. From intensive workshops led by renowned faculty to critical studies programs, artist residencies, and free lectures on contemporary art, we provide a nurturing environment where artists can explore, learn, and grow. We emphasize small class sizes to provide personal attention and foster direct faculty access. Our studios are available 24/7, encouraging unbridled creativity. We instill in our community the values of art as a way of life and a professional path, as well as the importance of giving more than one takes and creating for the enjoyment of others. Anderson Ranch's impact through art extends to both the on-campus community and the Roaring Fork Valley. Public Programs: The Ranch hosts a wide array of free public events, including lectures, tours, seminars, and exhibitions, with a primary aim of educating the public about art and artists. These initiatives have garnered significant attendance, with the Summer Series, featuring renowned artists, drawing over 700 participants. Latinx Outreach Program: Anderson Ranch initiated a comprehensive community outreach program to bolster services related to Latinx arts and culture in the regional community. This year-long, multifaceted program aimed to engage and unify diverse communities around the shared interest in Latinx arts and culture. The program's impact is evident in the successful 2022 Hispanic Heritage Celebration, which attracted over 600 attendees, a majority of whom were Latinx and had not previously visited the Ranch campus. This culturally responsive program has fostered inspiring engagement with educators, leaders, students, and the broader Roaring Fork and Latinx community. We prioritize education and development opportunities for our staff, faculty, and board members to fortify our commitment to equity and diversity. Acknowledging that our campus is situated on the traditional, ancestral territory of the Ute people, who called the Roaring Fork Valley home for over 800 years, Anderson Ranch is committed to honoring the Indigenous ancestors and residents of this sacred land. Through our mission, we pledge to promote a wide range of arts, cultures, and voices, partnering with and paying tribute to the Indigenous communities that enrich this hallowed ground where we learn, work, and create.
